RULES & REGULATIONS FOR PARTICIPANTS

- Each float must include 20 hours of time or \$200 invested in its decoration. Vehicles with business name on the side of the vehicle does not constitute as an entry, however if you are pulling a float, then it is fine. Limit 100 entries.
- No charge for not for profit organizations or Chamber Members. All other businesses need to contact the Chamber office.
- Entries will be juried prior to parade start-up, however preliminary jurying will be done upon receipt of application. If there are any questions, a member of the Parade Committee will contact you. Actual judging will be done throughout the parade route.
- All distinguished officials will appear in one location within the parade line-up (enter Borden St. off Route 120 by Goodyear).
- Political Candidates or Officials seeking or holding an office must be present in the parade - not just their vehicles and will appear in one location within the parade line-up (enter Borden St. off Route 120 by Goodyear).
- All city, township and county vehicles will appear in one location at the beginning of the parade line-up (enter Borden St. off Route 120 by Goodyear) and all fire trucks, snow plows and rescue vehicles (enter Main St. east of Route 31).
- Your parade day instructions will be online at www.mchenrychamber.com approximately one to two weeks before the parade. Included will be the assembly point location, parade route, time, pick-up and drop-off location, any last instructions and your position in the parade line-up. This verification sheet must be presented on parade day to the Parade Committee.
- Please note that THROWING OF CANDY OR ANY OBJECTS FROM THE FLOAT IS STRICTLY PROHIBITED, in the interest of safety to all. Candy and items can be handed out at edge of parade route. Infraction of this regulation will result in ejection from the parade immediately.
- NO ALCOHOL will be allowed to be consumed or present on any parade entries. Those violating this rule will be immediately removed from the parade and prosecuted by the McHenry Police Department as it would under normal open alcohol container laws.
- If all of the above rules and regulations are not adhered to, you will be refused participation in our 2010 Fiesta Days parade and any other future parades.
